



# Healthcare in the future - a secondary school challenge

## Rules

1. Access Health and Community (ABN **82 136 672 681**) (“AccessHC”) is conducting a Challenge called the “Healthcare in the future: a secondary school challenge” (“Challenge”).
2. These terms and conditions apply to the Challenge. By submitting your entry you agree to be bound by these terms and conditions. Any entry that does not comply with these terms and conditions may be deemed invalid and ineligible to win a prize.
3. The Challenge is open from 9am, 26 April 2019 to 5pm 6 September 2019 (“Challenge Period”). Any entry received after the expiry of the Challenge Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries. AccessHC reserves the right to extend the Challenge Period in its sole discretion.

## Entry

1. The Challenge is open to currently enrolled school students attending a secondary school in the Cities of Boroondara, Manningham and Yarra. Students may enter individually or in a group of up to 4 students.
2. Entrants are required to complete two steps: **1. Register** by 5 pm on Friday 26 April and **2. Submit entry** by 5 pm on Friday 6 September
3. All entrants must register for the Challenge on the official registration form at [www.accesshc.org.au/SchoolChallenge](http://www.accesshc.org.au/SchoolChallenge) Registration closes 5 pm Friday 26 April 2019
4. Entrants less than 18 years old must obtain the consent of a parent or guardian to enter, using the fields included on the registration form.
5. The Challenge: To develop a vision for healthcare in the future. Your entry can be in any of the following formats:
  - a poster
  - a recorded 5 minute video presentation uploaded to YouTube, or Vimeo
  - pictures
  - other media
6. Maximum file size size for digital entries is 20MB. If your email cannot send the file you can also send the file using WeTransfer or Dropbox, sending it to [challenge@access.org.au](mailto:challenge@access.org.au)
7. Video entries: If your entry is a video and its view settings are ‘private’ send the link to [challenge@accesshc.org.au](mailto:challenge@accesshc.org.au) including a password if applicable.
8. Poster entries: For physical posters you can post or deliver 283 Church Street, Richmond, VIC, 3121, Australia. Note if posting that we must **receive** the entry by 5 pm Friday 6 September
9. Entry into the Challenge is free.
10. Entrants may enter the Challenge once only.



11. By submitting an entry, each entrant warrants to AccessHC that:
  - (a) if below 18 years of age, they have the permission of their parent or guardian to enter the Challenge;
  - (b) the entry to the Challenge is the work of the entrant;;
  - (d) their entry, and AccessHC's use of their entry, will not:
    - infringe any person's copyright or other intellectual property rights;
    - infringe any person's privacy rights or any applicable privacy laws; or
    - breach any other laws.
12. Each entrant grants to AccessHC a perpetual, royalty-free licence to use, reproduce, publish and communicate their entry, including a right to sublicense it to other parties (including posting on AccessHC's social media accounts) in any format for the purpose of the Challenge and for AccessHC's marketing and promotional purposes.
13. Beyond the licence in point 8, the copyright to materials submitted Challenge submission remains with the creator, as required by the *Copyright Act 1968* (as amended).
14. Return of physical entries: Where the entry submitted is a physical object, such as a poster, AccessHC will negotiate the return of the entry to the creator of the item. If attempts to contact the creator and negotiate a return of the object have been unsuccessful, AccessHC reserves the right to dispose of any unreturned items after Friday 20 December 2019.

## Judging and Prizes

1. AccessHC will judge all valid entries received within the Challenge Period and select winners ("Prize Winners"). The Judging panel will be independent of AccessHC.
2. The Judging Panel will select up to 3 entries to win a prize.
3. The prizes will consist of: First prize: a pre-paid visa card to the value of \$500, Second prize: a pre-paid visa card to the value of \$250 and Third prize: a pre-paid visa card to the value of \$100. The prizes cannot be redeemed for cash. All winning entries will receive a prize certificate.
4. Where a winning entry has been submitted by a team, the prize is to be divided among the team members. The submitting team is responsible for allocating prize monies to individual team members
5. Prize Winners will be notified on Monday 28 October 2019 by email. The names of Prize Winners will also be published on AccessHC's website and social media accounts. All submissions will be displayed at a public event in November 2019.
6. Non-winning entrants will receive a thank you email and an invitation to attend the public event.
7. The decisions of AccessHC regarding Prize Winners are final and will be binding on each entrant. No correspondence or communications will be entered into. If after reasonable efforts a Prize Winner cannot be contacted, cannot accept a prize or is deemed to be ineligible to enter the Challenge, AccessHC reserves the right to select a different Prize Winner.
8. If any event prevents or hinders the Challenge or AccessHC's ability to deliver a prize, AccessHC may in its absolute discretion cancel the Challenge, select another Prize Winner or provide a similar prize of equivalent value.
9. AccessHC may refuse to award a prize, or seek its recovery, in the event of the relevant entrant's fraud, dishonesty, or non-entitlement under, or breach of, these terms and conditions. In the event of a dispute concerning the identity of the person who submits an entry, the entry will be deemed to have been submitted by the owner of the social media account on which the entry is posted.
