

Fee Schedule 2025

Access Health and Community (AccessHC) provides a range of health and community services. These services are available through a number of subsidised or non-subsidised means.

- Subsidised: For eligible persons service cost is partially paid for through government funding. Clients may pay a contribution towards the cost of service through a gap fee
- **Consumer directed:** Services are fully funded by the government through a person's National Disability Insurance Scheme (NDIS) or Home Care Package.
- Bulk-billed/No out of pocket fees: Urgent Care Clinics (UCC) Only- Services are fully subsided under Medicare. Clients accessing UCC services without Medicare will also not incur any out-of-pocket costs.
- **Self-funded:** Service cost are fully paid for by the client from their own funds.

Client Contribution

Where referenced in the Fee Schedule, client contribution refers to the out of pocket expense that a person is required to pay out of their own funds for subsidised services. This is applicable for services subsidised through

- Community Health Program
- Home and Community Care for Younger Persons (HACC-PYP)
- Commonwealth Home Support Program (CHSP)
- Medicare
- Public Dental

Fee Exemption Eligibility

Persons who are not required to pay a contribution for a service if they are:

- Aboriginal and Torres Strait Islander
- Experiencing or at risk of family violence
- Experiencing or at risk of homelessness
- Refugee and Asylum Seekers
- Children in out-of-home care and/or known to child protection or the Orange Door
- Do not have Medicare and are accessing Urgent Care Clinic (UCC) services.

Where a person does not meet the fee exemption eligibility and is unwilling or unable to pay, a Fee Waiver must be approved in line with AccessHC policy and procedures. Please discuss Fee waivers with your care provider or program manager.



Medicare Bulk-billing

- Medicare bulk-billing is not available for Allied Health, Mental Health services (excluding headspace), and Child and Family services
- In the Medical Practice bulk-billing is available for people who meet the Fee Exemption Criteria (above) or who have an eligible concession card (below)
- Urgent Care Clinic (UCC) services are fully subsided under Medicare

Income Assessment and Ranges

2. Allied Health

Self-Funded

The Appointment fee cost for person's accessing self-funded physiotherapy, dietetics, podiatry and diabetes nurse educator services in clinic or via telehealth (telephone or video) are charged on a per session basis, as they are usually provided at a standard duration.

Occupational therapy, Speech Pathology, and Allied Health Assistant services and all services delivered in the home/community settings are charged on an hourly basis, as their can be variability in the duration of service delivery. An additional travel fee will apply for all services provided in the home/community.

7. Urgent Care Clinics (UCC)

Clients accessing Urgent Care Clinic (UCC) services are fully subsided under Medicare. Clients accessing UCC services without Medicare will not incur any out-of-pocket costs.

Medicare benefits cannot be claimed when the medical costs relate to a compensable workplace injury or illness for which an insurer or compensation agency has accepted liability. Medicare is only billed if the relevant workers' compensation claim has not been approved.

8. Dental

Smile Squad

All Children attending Government Primary and Secondary School (Prep - Year 12) can now be offered care under the Victorian Government Smile Squad program. The service is at no additional cost to the client (No Client contribution = FREE).

9. Interpreter Fees
